Respective responsibilities of the body and the auditor

Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (ACHU0042)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- The Annual Return has not been signed in accordance with the Accounts and Audit Regulations 2015. Section 2 was signed before Section 1.
- Section 2, Box 9: Information received from the smaller authority indicates that the assets are stated at replacement value. Please note that proper practice, as specified in the Practitioners' Guide, only requires that assets are recorded at their original cost and no adjustment is required until disposal.
