#### Waltham, Brigsley & Ashby-cum-Fenby October Update

#### Crime

There have been seventeen crimes reported in the Waltham Ward during September.

During the early hours of 30<sup>th</sup> September an attempt was made to enter a garage at a property on Brigsley Road, Ashby-cum-Fenby by cutting a hole in the roof. No entry was gained. During the early hours of 1<sup>st</sup> October, it appears the would- be intruders returned and tried to enter the garage through the hole already prepared. They were disturbed and escaped without making entry or stealing property.

A laptop was stolen from the boot of an insecure car parked on Fairway overnight 25<sup>th</sup> & 26<sup>th</sup> September.

Damage to cars parked on Fairway x2. Damage to a car parked on Archer Road. A car being driven along the A18 at Barton Street near to East Ravendale was forced to stop by another vehicle. The occupants then attacked the car causing damage to the mirror.

#### Crimes include:

Two shop thefts from the Co-Op. Three assaults. Two minor public order offences. A report of harassment over a drug debt. There have been two reports of ASB. Neighbour disputes x5. Danesfield Avenue YCA throwing objects at house windows. Wheatfield Drive noisy party. Elm Road youths shouting, swearing lighting fires.
