22/040 Items for discussion

a) To further discuss the future of the village playground

The deadline for completion of this has been set by NE Lincs council as 1st August if we are to prevent the equipment being removed.

Parish council agreed to pay for the insurance as Village Hall Committee have declared they don't have enough funds coming in to cover it –

Councillors asked for clerk to get updated quote, they also need up to date information about what/who/how regularly inspections of equipment needs to be carried out. – NE Lincs council have said they will still include the Brigsley play equipment in the annual ROSPA inspections which they pay for.

Councillors agreed we would communicate with clerk by email to get this sorted by the deadline date. Also, to ask clerk to inform the relevant person(s) at the council of our intentions to take over the play equipment.

b) To receive update on the planters/plaque for the Queens Jubilee

Planters have been ordered and paid for by Lara, she will present the bill to the clerk in due course for payment.

Councillors to ask Clerk to enquire about any permissions required from highways about sighting the planters – Lara will produce a plan of proposed positioning for Clerk to use if required for getting permission.

- 1. After the recent speed survey, it was noted that the 30mph limit might be too low in some parts of the village/over the beck into Ashby-cum-fenby. Councillors to ask clerk to find out about possibility of requesting a change back to previous limits.
- 2. Chair brought it to our attention that the glass in the notice board by the village green has been broken possibly by youths seen hanging around that area late at night on a Thursday. it will need replacing he will get quote / arrange for that to happen. request clerk to report to relevant people police
- 3. Chair also noted the bridle path sign has been broken (near Church?) and will need reporting to "foot paths" officer.
- 4. Chair has made enquiries about a Queens Platinum Jubilee plaque/stone for the village green awaiting more information.
- 5. It has been noticed that there appears to be some work being carried out to correct the drainage / flooding of the footpath near the pumping station / Norman corner as the path has been closed for several days – looks like it is awaiting completion – Could Clerk get some confirmation of what work has been carried out?
